The Federal Committee will be held in a hybrid format. For the venue, we are waiting for a final confirmation from the Representation of the Free State of Bavaria to the EU, Rue Wiertz 77, 1000 Brussels. We also take the opportunity to thank the Representation for its hospitality and kind support

Delegates who cannot attend in person will be able to participate remotely, as foreseen by the statutes of the UEF in exceptional cases.
